The regular meeting of the City Council of Pewee Valley, Kentucky was held on Wednesday, September 6, 2023. In attendance were Mayor Bob Rogers, Council Members: Jim Allison, Paige Bjorn, Emily Rademaker, and Henry Walser. Also in attendance were City Attorney, John Singler, and city clerk Denise Haney

Mayor Rogers called the meeting to order at 6:30 PM and led in the Pledge of Allegiance to the Flag.

Henry Walser made a Motion to approve the August 2023 minutes of the City Council Meeting as written. Jim Allison seconded the motion, and all Council Members present voted in favor.

New Business –

Brian Fogle, assistant director of Oldham County Planning & Development, summarized for the council the Oldham County comprehensive zoning ordinance updates. The areas affected by the update are private clubs and event venues, agritourism buildings, golf driving ranges, school capacity standards, and solar energy systems. A motion was made for adoption of Ordinance 5, Series 2023, an ordinance regarding the adoption of the Oldham County comprehensive zoning ordinance update, by Henry Walser, seconded by Paige Bjorn, roll call vote was taken and approved by all council members present.

Mr. Allison would like to propose an ordinance for Pewee Valley restricting the use of motorized vehicles such as atvs and golf carts in certain areas with high traffic and higher speed limits to keep the streets safe for our residents. He would like to research the county and similar cities to see how they have addressed these issues.

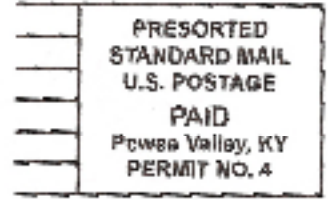
