

## CITY OF PEWEE VALLEY MINUTES OF CITY COUNCIL

Monday, July 2, 2018

The regular meeting of the City Council of Pewee Valley, Kentucky was held on Monday, July 2, 2018. In attendance were Mayor Bob Rogers, Council Members Henry Walser, Paige Bjorn, Norman Schippert, and Michele Pisano. Also in attendance were City Attorney, John Singler and clerk Denise Haney.

Mayor Rogers called the meeting to order at 7:00 p.m. and led in the Pledge of Allegiance to the Flag.

A motion was made by Henry Walser to approve the June 4, 2018 Minutes of the City Council Meeting as written. Michele Pisano seconded the motion and all Council Members present voted in favor.

### **Financial report – No report**

**Open Comments** –Houston Lane resident, Jim Allison, reaffirmed his concerns about widening the road and he requested an apology published in the Call of the Pewee from the council for the misleading article sent to residents with an erroneous picture of an accident which did not occur on Houston Lane. Mayor Rogers apologized and stated that he would address the council member that sent the article without approval and thanked Mr. Allison for his attendance and concerns. Residents want the council members to represent them honestly and if they cannot then they should reconsider their position on the council.
