Wednesday August 2, 2023

The regular meeting of the City Council of Pewee Valley, Kentucky was held on Wednesday, August 2, 2023. In attendance were Mayor Bob Rogers, Council Members: Jim Allison, Paige Bjorn, Emily Rademaker, Norman Schippert and Henry Walser. Also in attendance were City Attorney, John Singler, and city clerk Denise Haney

Mayor Rogers called the meeting to order at 6:30 PM and led in the Pledge of Allegiance to the Flag.

Henry Walser made a Motion to approve the July 2023 minutes of the City Council Meeting as written. Paige Bjorn seconded the motion, and all Council Members present voted in favor.
