MINUTES OF CITY COUNCIL  
Wednesday August 7, 2024

The regular meeting of the City Council of Pewee Valley, Kentucky was held on Wednesday, September 4, 2024. In attendance were Mayor Bob Rogers, Council Members: Paige Bjorn, Norman Schippert, Jim Allison, Emily Rademaker, Angelica Shea, attorney John Singles, and clerk Denise Haney.

Mayor Rogers called the meeting to order at 6:30 PM and led in the Pledge of Allegiance to the Flag.

Jim Allison made a Motion to approve the August 2024 minutes of the City Council meeting as written. Angelica Shea seconded the motion, and all Council Members present voted in favor.

### **New Business —**

Attorney Singles introduced by summary the second reading city of Pewee Valley Ordinance 4 Series 2024 an ordinance relating to prohibition of cannabis business operations in the city of Pewee Valley, Ky. A motion was made to accept the and approve Ordinance 4, by Paige Bjorn, seconded by Jim Allsion. A roll call vote was taken, and the ordinance passed with a 3 to 2 vote.

Open Comments — Resident Kenny Lanham thanked Chris Fitzner for his dedication to the city, his personal connections with families, and hopes for his continued work for the community. Resident Lisa Marcum asked about the status of hiring an officer. The mayor informed her that the ad is still running, the city has received a handful of applicants and will continue to collect resumes until September 18\*. She also asked about adding speed humps to Muirs Lane, which was part of the original paving plan. The mayor said the addition of speed humps would probably happen next summer.

Michael Logsdon asked about how to report streetlights that are out and if there is an ordinance about residents keeping their trees, grass and shrubs off the sidewalk, streets etc. The mayor said any nonworking streetlight can be reported to the clerk along with an address of a resident with overgrown vegetation and it will be addressed. He also asked if there would be an opportunity to meet the candidates running for council. The mayor will ask the women's club about having this event. Two flock cameras were installed in the city and the bum ban will be lifted October 1<sup>st</sup> unless conditions are extremely dry.
