COUNCIL MEETING

The regular meeting of the City Council of Pewee Valley, Kentucky was held on Wednesday, December 6, 2023. In attendance were Mayor Bob Rogers, Council Members: Jim Allison, Paige Bjorn, Emily Rademaker, Norman Schippert, and Henry Walser. Also in attendance were City Attorney, John Singler, and city clerk Denise Haney

Mayor Rogers called the meeting to order at 6:30 PM and led in the Pledge of Allegiance to the Flag.

Henry Walser made a Motion to approve the November 2023 minutes of the City Council Meeting as written. Paige Bjorn seconded the motion, and all Council Members present voted in favor.

Roads- (Bob Rogers) – The city has one, potentially two, paving projects for the spring. There has been a revision in the Locust subdivision plan, reducing the lots by one.

New Business –

Jim Urban, from OC Planning and Zoning, summarized the zoning text amendments for short term rental properties. The city does not allow short term rentals except in commercial zoning, the amendments pertain to the permit required and specifications under the permit. The floor was open for comments and none were made. A motion for second reading and passage of Ordinance 7, Series 2023 an Ordinance relating to short term rentals was made by Henry Walser, seconded by Paige Bjorn, a roll call vote was taken and all council members present voted in favor of the ordinance.

Mr. Allison proposed changes to the draft of a proposed ordinance for Pewee Valley (consistent with the state and Oldham County ordinances) regarding motorized vehicles. These revisions are in regard to restricting certain roads from motorized vehicles and restricting the speed limits when using skateboards, hoverboards, coaster sleds etc., and any penalties violating the proposed restrictions. Attorney Singler will draft an ordinance for review to present to the council.

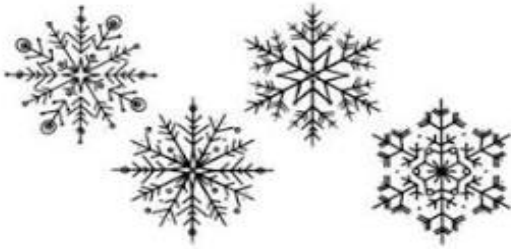

Ordinance 6, Series 2023 was printed incorrectly in the November Call of the Pewee and the following sections should have included the underlined:

(C) Camping on Abandoned Property Prohibited.

1) It shall be unlawful for any person to camp or set out camping paraphernalia on abandoned property within the city limits of Pewee Valley for more than four (4) consecutive hours during the hours of 8:00 a.m. to 8:00 p.m., without the permission of the landowner.

2) It shall be unlawful for any person to camp or set out camping paraphernalia on abandoned property within the city limits of the City of Pewee Valley during the hours of 8:00 p.m. and 8:00 a.m., without the permission of the landowner.

(D) Camping on Vacant Property Prohibited.

1) It shall be unlawful for any person to camp or set out camping paraphernalia on vacant property within the city limits of the City of Pewee Valley for more than four (4) consecutive hours during the hours of 8:00 a.m. to 8:00 p.m., without the permission of the landowner.

2) It shall be unlawful for any person to camp or set out camping paraphernalia on vacant property within the city limits of the City of Pewee Valley during the hours of 8:00 p.m. to 8:00 a.m., without the permission of the landowner.

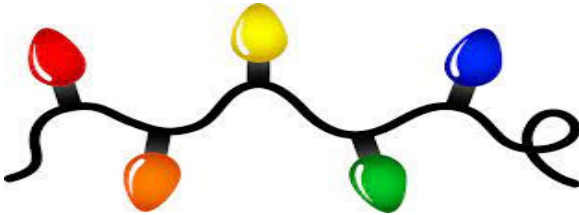

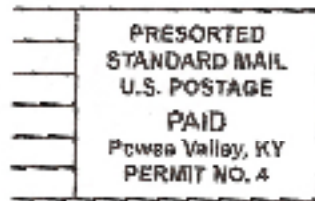
